TERMS AND CONDITIONS

1. An initial non refundable payment of \$500 + gst shall be made on the donor mare's arrival .
2. The cost of the recipient mare is due and payable on the 45-day pregnancy scan. The cost of the recipient mare includes all drugs and pregnancy scans due, up to and including the 45-day pregnancy scan. Agistment will be charged per day for the recipient after the 45-day pregnancy scan and billed to your account.
3. It is the client's responsibility to arrange transport for the recipient mare once the mare has been scanned 45 days in foal. Please notify Berragoon Breeders & ASH Stud a day prior to collection of recipient mare. If she is being collected on the weekend please call on the Thursday prior to the weekend so that we can have her ready for departure.
4. It is the client's responsibility to take care of the recipient mare and return her to Berragoon Breeders & ASH Stud once the foal has been weaned.
5. The cost of the transport to and from Berragoon Breeders & ASH Stud for the recipient mare is the owner of the embryo's responsibility. The client is responsible for any agistment that the recipient may incur while away from Berragoon Breeders & ASH Stud.
6. Please notify Berragoon Breeders & ASH Stud if the mare is ill, injured or loses the pregnancy or the foal dies. If the recipient mare contracts strangles, ringworm or any other contagious diseases please notify Berragoon Breeders & ASH Stud . All costs incurred to treat the disease is at the clients expense.
7. The recipient mare must be returned to Berragoon Breeders & ASH Stud in an acceptable condition.
8. If the recipient mare is to die, the replacement fee of \$770.00 will be billed to the client
9. Berragoon Breeders & ASH Stud will not be held responsible for any accounts payable for vet bills, transport or agistment due for the recipient mare - this is the responsibility of the client leasing the recipient mare.
10. It is agreed that all sums payable to Berragoon Breeders be paid by cheque to Berragoon Breeders , 'Mandaring', Holbrook NSW 2644 OR via internet banking to AA Mills & Family BSB: 082 406 ACC: 424 39 9780 and referenced with client surname and the invoice number issued with this contract. No Breeding Certificate will be issued until account for mare owner has been paid in full.
11. When client signs and returns both copies of this contract to Berragoon Breeders and the deposit is paid, it will then be a binding contract on both parties subject to the above terms and conditions. This contract is not transferable or assignable. One copy will be returned to client.
12. The recipient mare will not be released if this form has not been signed prior to departure.
