A booking fee of \$250.00 plus GST is payable (deductible/non-refundable) with this contract to confirm booking. The unpaid balance of the stud fee is to be paid when the mare is pronounced safe in foal at 45 days. No Breeding Certificate will be issued until account for mare owner has been paid in full.

- The quantity and quality of semen is deemed to have sufficient numbers and motility to obtain pregnancy under normal conditions if inseminated in 24 hours.
- It is further agreed that should a stallion die or become unfit for service, or the above named mare should die prior to pregnancy, then this contract shall become null and void, and any money paid as part of the booking fee shall be refunded less any applicable costs.
- Mare owner agrees that Berragoon Breeders will not be responsible for any disease, accident, sickness or death to mare owner's mare or foal.
- Mare owner agrees to have Berragoon Breeders veterinarian check mare owners' mare for normal breeding condition, and to perform such other veterinary services as Berragoon Breeders deems necessary, at mare owner's expense. This includes worming, treating for infections, preventative measures, original examination, ultrasound, etc.
- In the event that the mare aborts, dies or if the foal does not stand and nurse, it is agreed that another service will be supplied for a return breeding season and no stud fee will be charged for subsequent breeding. To be entitled to such subsequent breeding, the owner must deliver to Berragoon Breeders, a certification by a licensed veterinarian attesting that the mare aborted or that the foal failed to stand and nurse, accompanied by the Stallion Breeding Certificate, and such delivery shall be made within ten (10) days of the date that the mare aborts or the foal is born.
- It is agreed that all sums payable to Berragoon Breeders be paid by cheque to Berragoon Breeders, 'Mandaring', Holbrook NSW 2644 OR via internet banking to AA Mills & Family BSB: 082 406 ACC: 424 39 9780 and referenced with client surname and the invoice number issued with this contract.
- When mare owner signs and returns both copies of this contract to Berragoon Breeders and the deposit is paid, it will then be a binding contract on both parties subject to the above terms and conditions. This contract is not transferable or assignable. One copy will be returned to client.
